In 1993 the Royal College of Psychiatrists produced the first consensus statement¹ on the use of high dose antipsychotic medication (updated in 2014) as a result of a possible link between high doses of antipsychotics, ventricular tachycardia, sudden death and the increased incidence of side effects.

The Royal College of Psychiatry defines high dose antipsychotics use as: ' A total daily dose of a single antipsychotic which exceeds the upper limit stated in the SPC or BNF with respect to age of patient and indication being treated; and a total daily dose of two or more antipsychotics which exceeds the SPC or BNF maximum using the BNF percentage method ' .

The details of the clinical rationale for prescribing high dose antipsychotic therapy should be clearly documented within the patient ' s clinical notes. 4. The decision to prescribe high dose antipsychotic therapy and the rationale should be discussed with the patient and/or carer and valid consent obtained and documented. General

~~High Dose Antipsychotic Monitoring Policy~~

Patients treated with a dosage of 4 mg or less oral risperidone should receive 25 mg, while patients treated with higher oral doses should be considered for the higher dose of 37.5 mg. Sufficient antipsychotic coverage should be ensured during the three-week lag period following the first injection.

Oral risperidone should be given prior to starting the injection to assess tolerability and response. Patients stabilised on 4mg per day or less of oral risperidone should start on 25mg of the long acting injection. A starting dose of 37.5mg may be considered in patients maintained on higher oral doses.

The method used within HTNFT to calculate cumulative antipsychotic doses, the BNF % calculation method, converts the dose of each drug into a percentage of the BNF maximum recommended dose for that drug and then adds these together to attain a total percentage of the BNF dose. A cumulative dose of more than 100% is a high dose (see Appendix 1).
